Over the last year Yadkin County has held the line on spending and added approximately \$500,000 to the fund balance (Savings Account).

As we continued to make government more efficient and accountable, Yadkin County Government was presented with an Honorable Mention State Treasurer's Award for Excellence in Accounting and Financial Management out of 100 Counties and 552 Municipalities.

The tax rate of .69 remained the same in the FY12-13 Budget.

Some interesting facts:

- County property taxes amount to approximately \$19,000,000 in revenue for the County.
- In the month of August the County gives a 2% discount for early payment of taxes. During this month the Taxpayers of Yadkin County will pay approximately 55% of the outstanding taxes for the year.
- In the month of December, approximately 25% of the outstanding taxes for the year are collected.
- In the months of March and April, 10% to 15% of the outstanding taxes for the year are collected.
- The County exempts approximately \$250,000 in taxes each year for the elderly, disabled and veteran exemptions.
- There is \$2,620,948 in taxes deferred for agriculture and forestry use value program. Deferred means not collectable until sold or loses eligibility for the program.
- The county exempts \$1,290,681 in taxes for religious owned property and government owned property.
- The County collects motor vehicle taxes for all ten fire districts and the four towns in addition to the county tax. The County collects real and personal taxes for the county and all ten fire districts.
- The County is scheduled for another reappraisal of real property in 2015.
- The County offers a payment plan for taxpayers that will result in their current taxes being paid by the end of December each year.
- There are links from the County Website that allows taxpayers to check their property record cards, look up the deed for their property, look at the map of the County and locate their property, see what they owe and pay their taxes online.

## HOW TO CALCULATE A TAX BILL

The 2012 tax rate for Yadkin County is 0.69. This means property was taxed at 0.69 cents per \$100 value. If your home's appraised value is \$150,000:

$$\text{Formula } \$150,000/100 \times 0.69 = \$1,035$$

In addition to the \$0.69 county tax on your tax bill, there is also a fire tax. This tax is collected by the County and forwarded to each fire department. Below is the fire tax rate for each district. The rates are requested by each fire department and approved by the County Commissioners.

**FORECLOSURE:** The County has entered into a contract with Zacchaeus Legal Services to handle accounts reaching foreclosure. We turned over 128 parcels in the month of June 2012 and 6 parcels in the month of October 2012 for foreclosure. We will continue to provide Zacchaeus with accounts on a periodic basis. If you receive a registered letter from the County Tax office it would be to your best interest to contact the tax office as soon as you can, this is the first step in the foreclosure process. We are very committed to this project of getting taxpayers current with their taxes. It is important that everyone pay their fair share and that the taxpayers paying are not subsidizing for those who do not pay.



## SOUND FISCAL MANAGEMENT

The Yadkin County Commissioners mandated new professional administration of public purchasing and procurement on November 19, 2012.

Yadkin County now maintains a centralized countywide system of financial planning. The County maintains the accounting records of the County in accordance with General Accepted Accounting Principles of the Local Government Commission. New policies and practices certify that systems and records are of an accurate representation of the overall fiscal management of the County.

The County's newest and most sweeping improvement in financial management is the a purchasing policy approved and directed for implementation by the Board of Commissioners November 19, 2012.

## STATEWIDE RECOGNITION

Yadkin County was awarded an Honorable Mention State Treasurer's Award for Financial Excellence. Yadkin County has successfully transitioned to utilization of a central depository consolidating 16 manual checking accounts into one accounts payable account. The county purchased the Munis Financial System in 2004 and only processed general fund transactions through Munis. All other checks were written in duplicate copies and then entries were made into Munis to reflect transactions.



The County maintained 17 checking accounts at its central depository of SunTrust. These individual checking accounts included 16 different manual checkbooks. Effective January 1, 2011, the County began utilization of the central depository system within Munis and closed 11 of the individual checking accounts.

The cost savings have allowed the county to add services such as positive pay and ACH Fraud Control to protect the County's funds. The Finance Department is now performing at a higher level, more efficiently and more transparent.

MVP Group International and their Colonial Candle division have entered into a lease purchase agreement to occupy the Vaughan Bassett Furniture building in Boonville. The facility will handle warehousing and distribution in support of Colonial Candle's manufacturing facility in Elkin.

No major changes are expected to affect the Yadkinville operation. ### The Economic Impact on Travel in Yadkin County

Visitors traveling to and within the state of North Carolina spent a record \$18 billion in 2011, supporting more than 40,000 North Carolina businesses and directly supporting nearly 200,000 jobs all across the state. State and local tax revenues generated as a result of visitor spending totals more than \$1.5 billion annually. North Carolina ranks as the 6th most visited state in the United States. The state's natural scenic beauty, rich history and culture, vibrant cities, quaint small towns, and central east coast location make it an ideal travel destination. And, the abundance of direct air access into the state from national and international destinations around the globe have helped to position it as preferred international travel destination.

#### Yadkin County Statistics on Tourism for 2011:

- Domestic tourism in Yadkin County generated an economic impact of \$31.31 million in 2011, an increase of 6.60 % from 2010.
- In 2011, Yadkin County ranked 70 in travel impact among North Carolina's 100 Counties.
- More than 320 jobs in Yadkin County were directly attributable to travel and tourism.
- Travel generated a \$5.20 million payroll in 2011.
- State and local tax revenues from travel to Yadkin County amounted to \$2.48 million. This represents a \$64.79 tax saving to each County resident.

A new project funded by the Yadkin Arts Council and the Tourism Development Authorities of Yadkinville and Yadkin County is taking shape -- a Quilt Trail. The Quilt Trail will feature unique quilt blocks on barns, buildings and houses in the County. The Quilt Trail purpose is to honor quilting traditions, beautify the community, promote cultural heritage tourism, farming traditions, and agri-tourism. The trail currently has 30 quilts lovingly painted and located on various barns and businesses throughout the county. More quilts are being added as interest increases, and a printed brochure is being produced and will be available at the Visitor's Centers in Yadkinville and Jonesville.



## AGRICULTURE / EDUCATION CENTER

The proposed Yadkin County Agricultural / Education Center is planned to be built in the area behind the Surry Community College Yadkin Center off Highway 601 North.

The center will feature eight classrooms, a cafeteria for Surry Community College and Yadkin Early College Students and several multi-purpose rooms on the lower level.

The upper level is slated to have a separate entrance from Highway 601. This level will house Cooperative Extension, NC Forestry, Natural Resources Conservation, Soil & Water and the United States Farm Service Agency.

The upper level will also provide a 300 person banquet hall conference center, commercial kitchen and a demonstration kitchen.

The proposed facility will be approximately 35,000 square feet. The projected cost will depend on several variables. An estimated cost per square footage between \$135 to \$200 square feet could equate to a cost ranging between \$4 million to \$7 million. However the county has secured \$178,000 in grants to date from the following:

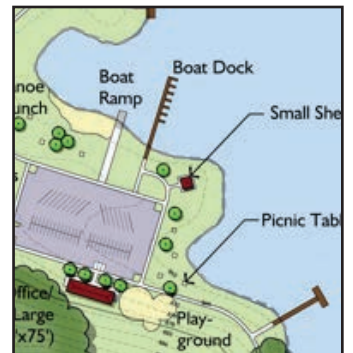
# Yadkin County Parks & Recreation



Developing and maintaining parks improve the quality of life and spur economic development. The number, quality and condition of parks increase the likelihood of job creation. Business and industry look at parks when looking for new areas to grow or move their companies.

## 5D RESERVOIR PARK

Last year, the Board of Commissioners voted to create a comprehensive recreation system-wide plan (Master Plan) and two site specific plans. After the creation of the plan, the Commissioners applied for a grant with the North Carolina Parks and Recreation Trust Fund (PARTF) to create a passive / natural park at the 5D Reservoir. In late 2012 the Governor of North Carolina announced that Yadkin County had been awarded a \$500,000 matching grant from PARTF. The construction of the new park is expected to begin in mid to late 2013.

We are planning to complete the construction of two new parking lots which will allow residents the opportunity to park closer to the fields in which their children are participating in sports.



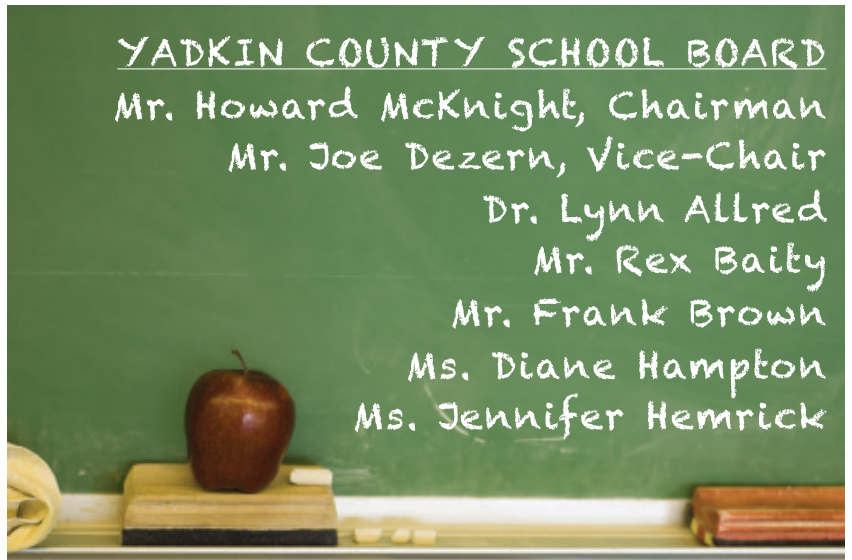
Preliminary Draft Design of New Parking Lots

The County Attorney is appointed by the Commissioners to advise the Board, the County Manager, and County Department Heads on all legal matters related to the operation of County government. The County Attorney is responsible for seeing to it that the affairs and actions of Yadkin County are conducted in accordance with federal, state, and local laws. Legal opinions are provided on all laws, contracts, leases, resolutions and other legal documents.

Mr. Powell a Davie County native graduated from both the University of North Carolina and the Wake Forest University School of Law. Immediately after law school and after passing the North Carolina Bar, he was drafted into the U. S. Army by the Davie County Board of Selective Service. After two years of service at Ft. Bragg, NC, Ft. Bliss, Texas, and Long Binh Post, South Vietnam he was awarded the Bronze Star Medal. He established his law practice in Winston-Salem after the service.

Since then, he has practiced law primarily in the courts of Davie, Davidson, Forsyth, Stokes, and Yadkin counties. During this time, he was elected to the N. C. State House, served on the N. C. Board of Transportation, served our State as the Commissioner of Motor Vehicles. In June, 2006, he was appointed by the Stokes County Board of Commissioners as their County Attorney and has served continuously in that position since then.

## Message From The Sheriff

The Office of Sheriff has a long and proud history that began in the middle ages approximately 1200 years ago. In those days the Sheriff was appointed by the King to keep the peace and care for the people in the towns and counties under his rule. It was considered a great honor to be called upon to serve as Sheriff, and if called upon, the person had to serve as well as any citizen called upon to serve by the Sheriff. The Office of Sheriff traveled from England to the colonies where one of the first Sheriffs was elected in Virginia in 1651. Unlike the 1600's the Sheriff's responsibilities are no longer just enforcing the law and keeping the peace. Today the Sheriff provides security for the courts, maintains and operates county detention facilities, and serves civil and criminal processes. In recent years we have been given the duties of maintaining the counties sex offender registry, processing and issuing concealed carry permits, and collecting DNA samples from individuals convicted of certain crimes. Over the years the equipment, technology, and techniques used in law enforcement have changed drastically. Unfortunately we only need to pick up a newspaper, turn on the television, or go to the internet to see how drastically criminal behavior has also changed.

Although it has been over 1200 years since the Office of Sheriff was established, I believe some of the most important things have not changed. The Sheriff's priority still needs to be focused on serving the citizens of their county. As your Sheriff, I consider it a great honor to have been selected to serve you. Since I took Office some of my priorities have been to focus on property crimes such as breaking and entering, drug violations, and crime prevention. The employees of the Yadkin County Sheriff's Office have supported these priorities and together we have made significant progress. Many citizens of this county have also assisted in our efforts and for this I am grateful.

In 2013 the Sheriff's Office will not lose sight of these same priorities and will strive for continual progress in these important areas. The Yadkin County Sheriff's Office has several new programs and services planned for the citizens of this county. In January we plan to kick off a Building Identification program. This program will collect information on all commercial and religious buildings in the county. The data such as ownership and emergency contact information will be entered into a data base in our communications center, which will assist in more timely notifications in case of criminal activity, fire, or security issues at the property.

The Sheriff's Office will also start a series of community meetings in January that will be held at each of the Fire Departments in the County. The dates, times, and locations will be advertised during the next year. The purpose of these meetings will be to discuss law enforcement issues in your neighborhood, and to present the various crime prevention programs that are now available to you from the Yadkin County Sheriff's Office. Stopping crime before it happens, and keeping you from becoming a victim is our goal. As the Sheriff's called upon the people over 1200 years ago, I am asking you to assist me in making Yadkin County one of the safest and crime free counties in the Nation. I sincerely believe that working together we can make this happen.

**\*County Communications (911 Center)-** the ability to map your location and get emergency responders to you more quickly, reducing our response time.

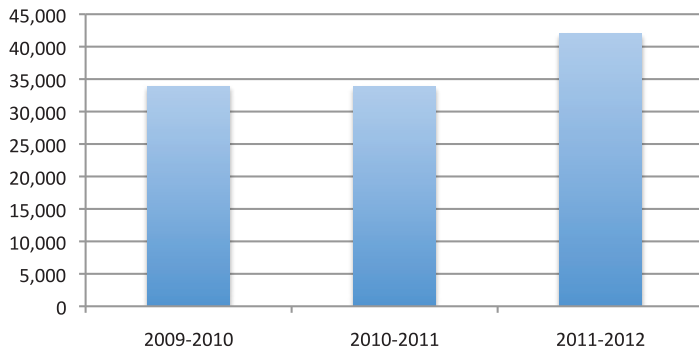
**\*Sheriff's Webpage-** keeping you informed with links to specific services, emergency notifications and links to other important resources (sex offender registry, crime prevention information).

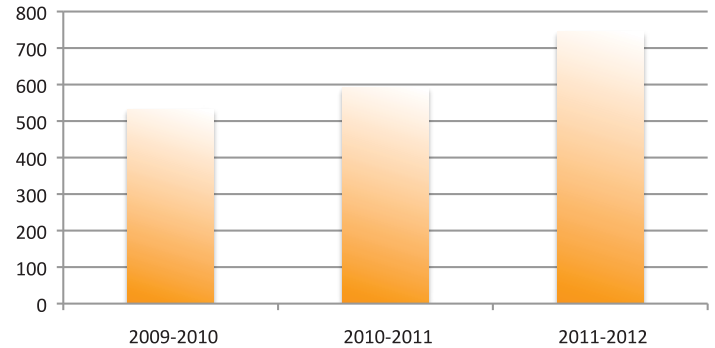

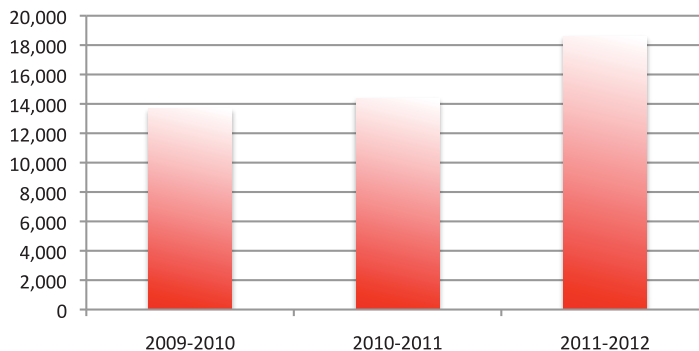
### Entered Calls for Service



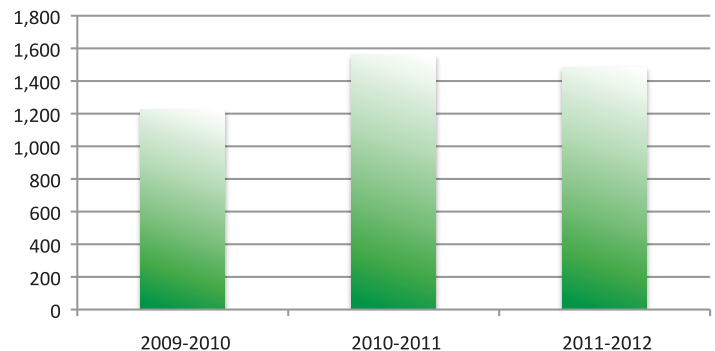
### Citations Issued



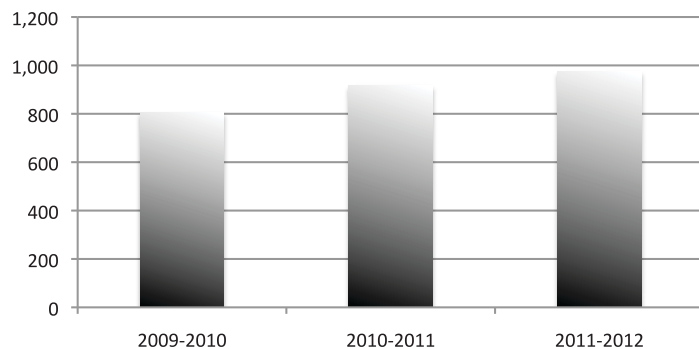

## What is Emergency Services?

In general Emergency Services ensure public safety and health by addressing different emergencies. In Yadkin County the Emergency Services Department includes Emergency Management, Emergency Medical Services (EMS) and the Office of the Fire Marshall. Most everyone is familiar with EMS or ambulance service as well as the function of the Office of the Fire Marshall. Case in point: most everyone knows someone that has been in an ambulance and we all remember seeing the Fire Marshall inspect our schools. However Emergency Management fortunately has likely not touched your life. This year's portion of the Report to the People on Emergency Services will **focus on explaining Emergency Management**. The organizational chart below will give you a picture of how our Emergency Services is Organized.

## What is Emergency Management?

If you have seen the 1997 film

Volcano starring Tommy Lee Jones you have a good idea. In the movie, Jones was the head of a crisis agency called the Office of Emergency Management. In the movie his character attempts to divert the path of a dangerous lava flow through the street of Los Angeles following the formation of a volcano. **Emergency Management is the managerial function charged with creating the framework within which communities reduce vulnerability to hazards and cope with disasters.**



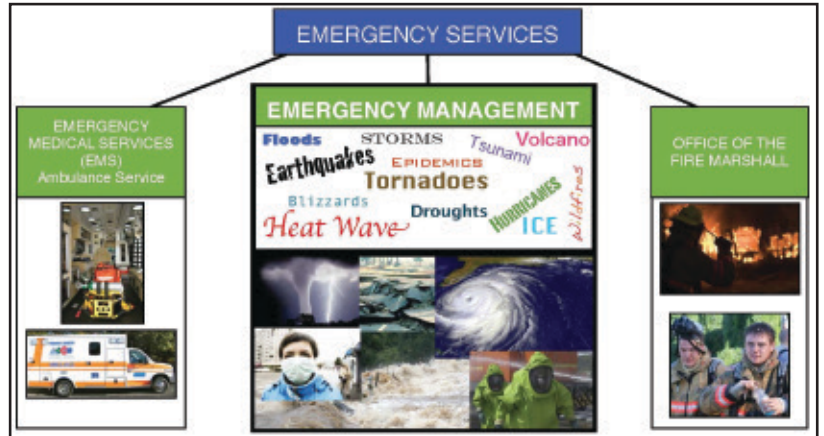
## What is Yadkin County doing to help citizens in an emergency?

Several things! In the last year under the leadership of Keith Vestal director of Emergency Services we have responded to or assisted with the management and preparation for two hurricanes, multiple severe thunderstorms, and several hazardous material and fuel spills. Currently we are participating with other counties in a grant to fund a Regional Hazard Mitigation Plan. This will be a considerable cost savings to our county if awarded.

As we have consolidated the EMS, Emergency Management, and Fire Marshal into Emergency Services the County relocated Emergency Services to the west wing of the Hospital to meet their needs of and operations. They've have had the need of a building that could house our entire operation.

County employees have completed the majority of the renovations themselves and this facility will give Yadkin County the first true Emergency Operations Center (EOC). The facility is morphing into a state of the art facility that folks from around the state are visiting and planning future training events in. An EOC is a central command or control facility where emergency / disaster management functions are managed during an emergency situation. In a nutshell when disaster hits Yadkin County professional emergency management staff will be managing the overall strategic plans from this location.

Yadkin County is proactively mitigating and preparing for emergencies and is positioned well to respond and recover from a natural disaster or other emergencies.

# PROVIDING WATER

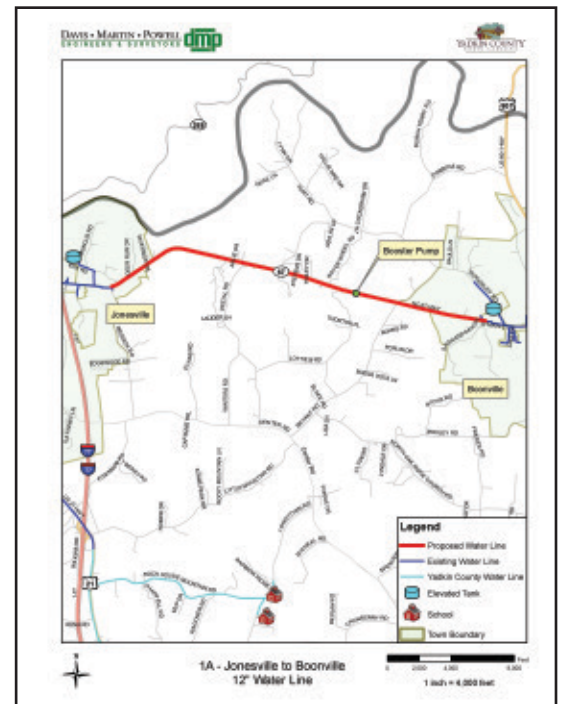
Last year, the County retained Davis-Martin-Powell & Associates, Inc. to complete a Comprehensive Enterprise Business Solution (EBS) for Countywide Water. The EBS has been completed with hydraulic modeling and preliminary conceptual designs for water construction and delivery.

The EBS included meetings with stakeholders across the County including business leaders and elected officials from each municipality. The meetings addressed water quality, rights, participants, phases and cost. The general consensus from the meetings was that Yadkinville and Jonesville are positioned well to provide potable water to their citizens for many years to come and that the County as a whole should focus on providing potable water to Boonville and East Bend.

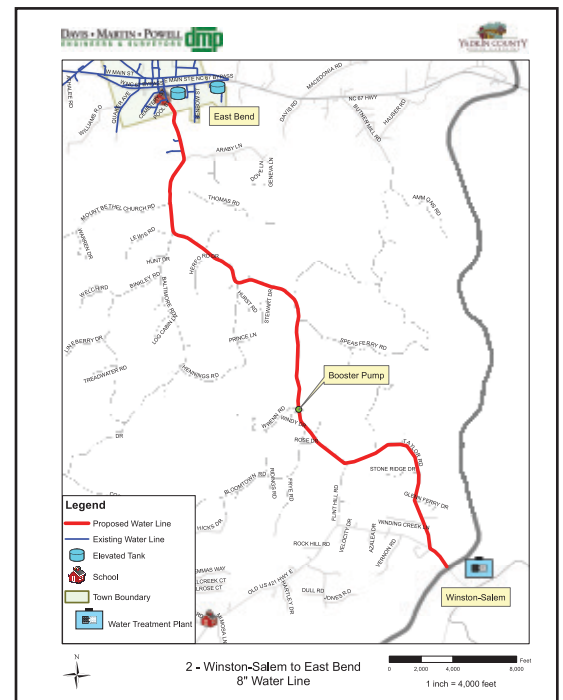
After the completion of the EBS, many meetings and consensus building, the Yadkin County Board of Commissioners passed resolutions pledging \$500,000 to both Boonville and East Bend for water infrastructure. Thereafter, the following ensued:

**BOONVILLE:** Boonville is currently working with the USDA on securing federal grants and loans to construct a water line between Boonville and Jonesville running on HWY 67. The County has agreed to provide \$500,000 in funding once a memorandum of understanding is complete to assist in providing potable water.

**EAST BEND:** Yadkin County is currently negotiating with the Winston-Salem/Forsyth County Utility Commission to purchase potable water at the raw water pump station located on the Yadkin River near Enon. The County has also met with the USDA several times and are in the process of applying for federal grants and loans to construct an 8 inch water line from the Forsyth County Line to East Bend traveling along Taylor and Flynt Hill Road.

The Board of Elections holds elections every year. Federal, State and County every other (EVEN) year and Municipal every other (ODD) year. The Health Department provides many state mandated services, including: **Environmental Health** - Provides consultation and services for approximately 1800 citizens and organizations through the inspection and permitting of food and lodging facilities, public swimming pools, on-site sewage systems and the private well program. **Clinic** - Provides care through Child Health, Family Planning, Maternal Health, and Adult Health programs. Provides mandated services through 500 immunizations encounters and communicable disease programs. **WIC/ Nutrition** - A federally funded supplemental nutrition education program funded by the USDA for infants, children and pregnant, postpartum and breastfeeding women. The Yadkin WIC office serves a monthly caseload of approximately 1250 participants. **Vital Records** - Provides the registration of all home births and deaths in Yadkin County and issues all permits for Burial Transit and Disinterment/ Reinterment.

The Health Department also provides the following services: Care Management, Health Education, Community Outreach, Dental Services and Mammograms through a Susan G. Komen grant for uninsured women.

The Register of Deeds Office serves as custodian and manager of a large number of public records. The records are recorded and maintained in accordance with the NC General Statutes and open for public inspection. The records include: Deeds, Deeds of Trust, Powers of Attorney, Separation Agreements, Plats, Cancellations and other miscellaneous documents. The Register of Deeds issues Marriage Licenses, indexes and issues certified copies of birth, death, and marriage licenses. They index military discharges and oaths of office. The Register of Deeds records approximately 4,500 documents a year, processes approximately 60 foreclosures, issues approximately 300 marriage licenses. The Register of Deeds collects approximately \$220,000 a year in revenue.

The Department of Social Services provides various services to strengthen families, assure safety, promote self-sufficiency, eliminate poverty and improve the quality of life for citizens of our County.

Some of the mandated federal and state services include Food and Nutrition Services, Family and Children's Medicaid, NC Health Choice, Adult Program Medicaid, Special Assistance, Subsidized Child Care. County residents must meet eligibility requirements to be eligible for these programs. DSS also protects children through Child Protective Services, Foster Care & Adoption Services. Foster Home recruitment, training and licensing is available as well. Social Services protects our elderly and disabled adults through Adult Protective Services. Our Department also has the monitoring responsibility of the four adult care homes in the County through the Adult Home Specialist Social Worker.



DSS also provides Community Alternatives Program for Disabled Adults-CAP/DA as well as Adult Guardianship services. Child Support Enforcement Services are available to any resident of Yadkin County who has custody of a child that needs support. A fee maybe charged for this service. Emergency Assistance is also available for one-time crisis related emergencies for citizens of our County. Funds are also available through the state CIP program for eligible citizens when they experience a heating or cooling related crisis. DSS also administers the LIEAP (Low Income Energy Assistance Program) for citizens of our County who met the eligibility requirements. Social Services make sure the less fortunate in Yadkin County are not forgotten.

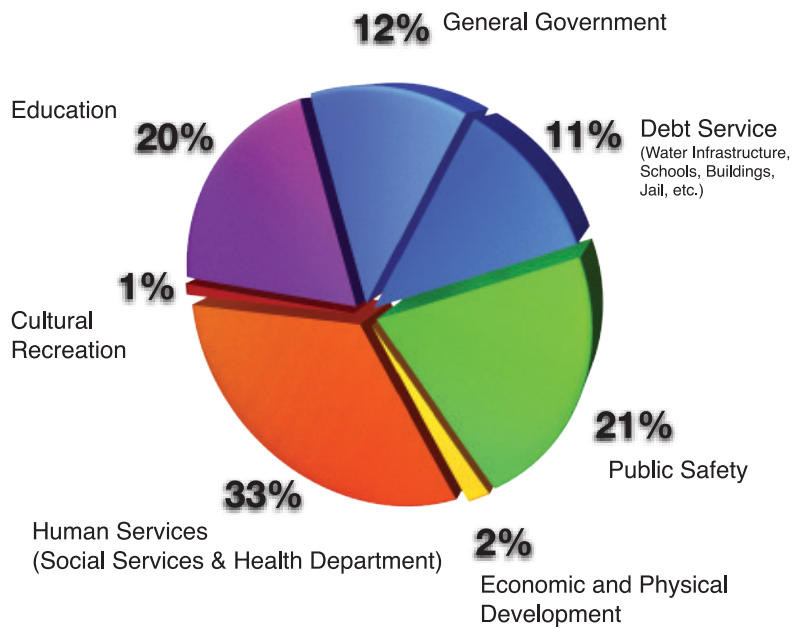
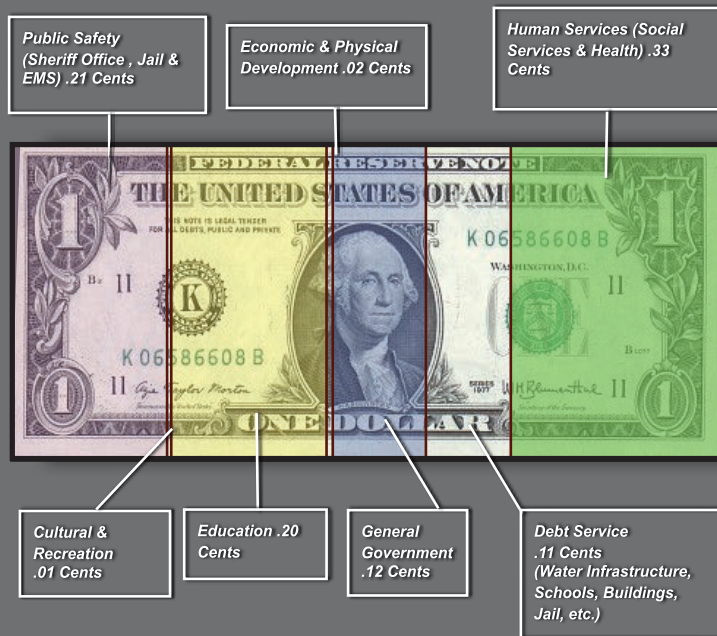
